### **Resolution #2023-10**

#### **2023 Saginaw County Multijurisdictional Hazard Mitigation Plan**

At a meeting of the Township Board for the Township of Birch Run, Saginaw County, Michigan, held on the 11<sup>th</sup> day of July 2023.

The following preamble and resolution were offered by R. Kiessler and seconded by C. Trinklein.

A resolution of Birch Run Township adopting the Saginaw County Multijurisdictional Hazard Mitigation Plan.

**WHEREAS**, the Birch Run Township Board of Trustees recognizes the threat that natural hazards pose to people and property within Saginaw County; and

**WHEREAS**, Birch Run Township has participated in the multi-hazard mitigation plan update, hereby known as the Saginaw County Hazard Mitigation Plan – April 2023 in accordance with federal laws, including the Robert T Stafford Disaster Relief and Emergency Assistance Act, as amended; the National Flood Insurance Act of 1968, as amended; and the National Dam Safety Program Act, as amended.

**WHEREAS**, the Saginaw County Hazard Mitigation Plan – April 2023 identifies mitigation goals and actions to reduce or eliminate long-term risk to people and property in Birch Run Township from the impacts of future hazards and disasters; and

**WHEREAS**, adoption by the Birch Run Township Board of Trustees demonstrates its commitment to hazard mitigation and achieving the goals outline in the Saginaw County Hazard Mitigation Plan – April 2023.

**NOW THEREFORE, BE IT RESOLVED** by the Township of Birch Run that:

#### **SECTION I:**

In accordance with Board Rules, the Birch Run Township Board adopt the Saginaw County Hazard Mitigation Plan – April 2023. While content related to Birch Run may require revisions to meet the plan approval requirements, changes occurring after adoption will not require Birch Run to re-adopt any further iterations of the plan. Subsequent plan updates following the approval period for this plan (2023-2028) will require separate adoption resolutions.
