## MICHIGAN DRAIN CODE

**Intercounty Drain Petition** 

(P.A. 40 of 1956 as amended, MCL 280.192 Chapter 8)

PETITION FOR CLEANING OUT, RELOCATING, WIDENING, DEEPENING, STRAIGHTENING, TILING, EXTENDING, OR RELOCATING ALONG A HIGHWAY FOR AN INTERCOUNTY DRAIN OR DRAINS OR ANY PORTION THEREOF

To the Public Works Commissioner of the County of Saginaw.

Petitioners hereby petition for cleaning out, relocating, widening, deepening, straightening, tiling, extending, or relocating along a highway of the drain known and designated as the <u>Clark</u> Intercounty Drain, located and established in the Townships of <u>Birch Run, Vienna, Thetford, and Arbela</u>, in the County(ies) of <u>Saginaw, Genesee and Tuscola</u>, State of Michigan.

Your petitioners respectfully declare that they constitute a number of freeholders in said Drainage District whose lands would be liable to an assessment for benefits equal to or greater than fifty percent of the number of freeholders whose lands would be traversed by the drain petitioned for, or abut on the part of any highway, between the point where said drain enters such highway, and the point where it leaves such highway or street or constitute a municipality representing such freeholders.

You petitioners further show that the said drain needs cleaning out, relocating, widening, deepening, straightening, tiling, extending, or relocating along a highway commencing on the South bank of the Horton and Graham drain in said Township of Birch Run, Saginaw County, Michigan, at a point 24 feet east of the section line between Sections 25 and 26, and 1778 feet north of the quarter post between said Sections 25 and 26 and extending approximately to a point located 12' East and 856' South of the Northwest corner of the Southwest 1/4 of the Southwest 1/4 of Section 1, T.9 N.-R.6 E., Vienna Township, Genesee County and the said cleaning out, relocating, widening, deepening, straightening tiling, extending, or relocating along a highway of such Drain or any part thereof, will be conductive to the public health, convenience, and welfare of Birch Run Vienna, Thethford, and Arbela Townships.
