AN ORDINANCE TO EXEMPT BIRCH RUN TOWNSHIP FROM THE STATE CONSTRUCTION CODE OF 1972, AND TO ADOPT THE 1994 EDITION OF THE UNIFORM BUILDING CODE.

THE TOWNSHIP OF BIRCH RUN ORDAINS:

SECTION 101. TITLE

This Ordinance shall be known as the Birch Run Township Building Code.

SECTION 102. PURPOSE

It is the purpose of this Ordinance to regulate the erection, construction, enlargement, alteration, repair, moving, demolition, conversion, occupancy, equipment, use, height, area and maintenance of all buildings or structures in the Township of Birch Run: and, to further provide for the issuance of permits and collection of fees and levy of penalties for the violation of provisions as set forth.

SECTION 103. EXEMPTION FROM STATE CONSTRUCTION CODES

Pursuant to Section 8 of Act 230 of PA 1972, the Township of Birch Run hereby elects that it shall be exempt from the State Construction Codes.

SECTION 104. ADOPTION OF UNIFORM CODE

The Township of Birch Run elects to adopt the <u>Uniform Building Code</u>, 1994 Edition, published by the International Conference of <u>Building Officials</u>, one copy of which is on file in the office of the Township Clerk, and made a part hereof as if fully set out in this ordinance.

SECTION 105. REPEAL AND SAVING CLAUSE

All other ordinances or parts of ordinances inconsistent or in conflict are repealed. This repeal shall not abate any action now pending under or by virtue of the ordinance repealed, nor shall the repeal discontinue, abate, modify or alter any penalty accrued or to accrue or effect the rights of any person, firm or corporation, or waive any rights of the Township of Birch Run, under action of the ordinance repealed existing at the time of the passage of this ordinance. It shall be considered that this ordinance is repealed upon the effective date of this ordinance.

SECTION 106. EFFECTIVE DATE

This ordinance shall become effective 30 days from the date of publication.
