WHEREAS, it is determined to be necessary and desirable, and in the best interest of the Township, to provide adequate sewer and water facilities ("Facilities"), and

WHEREAS, in order induce developers and land owners to provide adequate sewer and water facilities, it is essential that adequate financing be arranged through the issuance of municipal bonds, to be paid through levy of special assessments, impact and hook-up fees, and

WHEREAS, the Township Board is willing to assist developers and land owners in arranging financing and reimburse developers and land owners who provide facilities which assist and serve other areas located outside their individual subdivision or land area.

NOW, THEREFORE, BE IT RESOLVED that:

- In order to provide organized and beneficial growth in the community, the Board will, upon proper application by a developer or land owner, consider any proposed residential or development ("Project") request for financial commercial assistance.
- If the Board determines it to be necessary and desirable for the Township to finance all or part of the cost of installing a sewer and water project, it will:
 - Establish a special assessment district consisting of the area to be developed and issue bonds pledging the full faith and credit of the Township, subject to approval the Municipal Finance Commission.

- B. Reimburse the land owner or developer for pre-determined costs incurred in developing the project, which are necessitated by future anticipated construction outside the project area. Funds for reimbursement will be raised by charging the owners of any new Project benefited by the facility incorporated in the Project, a tap-in fee for each unit serviced by the water or sewer facility.
- C. Assist the developer in obtaining funds from the Birch Run Township Downtown Development Authority.
