(ORDINANCE NO. 95-1 - SERVICE CONNECTION FEE RESOLUTION)

At a regular meeting of the Township Board of the Township of Birch Run, Saginaw County, Michigan held on the <u>14th</u> day of March , 1995, at <u>7:30pm</u> o'clock, Eastern Standard Time.

The following resolution was made by Russell and seconded by DiBerardino :

WHEREAS, Ordinance No. 95-1 provides that Service Connection Fees are to be paid by the owners of certain Dwelling and Commercial Units within Birch Run Township which connect to a watermain; and

WHEREAS, Ordinance No. 95-1 provides that the Service Connection Fee charged to each Dwelling or Commercial Unit shall be established by the Township Board.

NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS:

The Service Connection Fees required by Ordinance No. 95-1 shall be as follows:

SECTION 1 - RESIDENTIAL CONNECTION FEES

A. Single Family Units or Premises:

Water District No. 1:

South on Dixie from Townline to 11580 Dixie. East from Dixie on Townline to 8715 Townline. West from Dixie on Busch to 7220 Busch. West from Dixie on Rathbun to Township Line. East from Dixie on Downing to 9769 Downing. West from Dixie on Canada and Canadaway to 10745 Canadaway. West from Maple to 7420 Canada. North on Maple from Village limits to Rathbunway to Rathbun. South on Maple from Rathbun Rd. to 10525 Maple. West on Birch Run Road for Village limits to Elms Road. (Appendix 1)

Service Connection Fee - \$3,200.

Water District No. 2:

East off Dixie on Busch to Maple then North on Maple to 8280 Maple. West on Lange off Maple to 8280 Lange. East off Dixie on Rathbun to 8710 Rathbun. East off Dixie on Canada to 1145 Canada. South from Canada on Gera to

11900 Gera. East off Gera through Shady Oak Subdivision. Elms Road north of Birch Run Road to Canada Road North off Canada on Beyer to 12935 Beyer. (Appendix 2)

Service Connection Fee - \$3,200.

Water District No. 3:

Starts East of 8715 Townline Road to Dehmel Road South from Townline Road on Beyer Road to 8435 Beyer. East on Canada Road from 11145 Canada to Pagles Road to Downing Road and North on Downing to Block Road South on Beyer Road from the Village limits to 12636 Beyer Road. (Appendix 3)

Service Connection Fee - \$5,500.

North off Dixie on Maple Road to 9505 Maple. (Appendix 4) Service Connection Fee - \$5,660.

Water District No. 5:

East on Townline from Dehmel Road to Gera Road. Then South on Gera Road to 8956 Gera. East off Gera through Evergreen Subdivision. South on Beyer from 8435 Beyer to 9933 Beyer. East off Beyer on Lange Road to 11250 Lange. North on Dehmel off Lange to 8330 Dehmel and South off Lange on Dehmel to 8670 Dehmel. East off Beyer on Busch to 9495 Busch. (Appendix 5)

Service Connection Fee - \$5,900.

Water District No. 6:

South on Dixie from 11580 Dixie to 12126 Dixie. West off Dixie on Birch Run Road to 9230 Birch Run Road. East off Dixie on Birch Run Road to 9700 Birch Run Road. (Appendix 6)

Service Connection Fee - \$5,500.

Water District No. 7:

(Appendix 7)

Service Connection Fee - \$5,900.

B. Duplex Connection Fee:

A Service Connection Fee for a duplex unit, shall be equal to 1.5 times the single family unit fee for the district wherein the duplex is located. The owner thereof is entitled to two (2) separate meters and lines, if requested, by paying to Birch Run Village two (2) meter charges.

C. Multiple Family Dwelling Service Connection Fee:

Multiple family dwellings shall be charged the single family unit rate for the first unit within the district it is located and the remaining units shall be charged one-half (1/2) the single family unit rate for each additional unit or if the multiple family dwelling has a single meter, the commercial rate for Service Connection Fees as set forth herein, shall be used.

D. Calculating Service Connection Fee for New Subdivisions:

The formula for determining Water District Service Connection Fees for New Subdivisions, wherein the Developer pays the cost of installing the Water Supply System, shall be equal to the Service Connection Fee charged the adjacent water district to which the subdivision is being connected, multiplied by the number of lots in the subdivision, minus the developer cost of installing the watermain system, divided by the number of lots in the subdivision.

The Connection Fee for Commercial units shall be as follows:
