**BIRCH RUN TOWNSHIP ELECTION COMMISSION  
RESOLUTION ON REGULAR AND SCHOOL ELECTION PRECINCTS  
NO. 05-02**

**At a Regular Meeting of the Birch Run Township Election Commission, Township of Birch Run, Saginaw County, Michigan, held at the Township Office on the 4<sup>th</sup> day of March, 2005, at 11:00 am o'clock Eastern Standard Time.**

**PRESENT: Clerk Amy Cook, Supervisor Earl Schlegel, and Treasurer Debbie Trevino,  
ABSENT: None**

**The following resolution was made by Trevino and seconded by Schlegel**

**WHEREAS, there is a need to move polling locations to accommodate voters and to facilitate elections in Birch Run Township; and**

**WHEREAS, the State of Michigan has adopted legislation to consolidate elections; and**

**WHEREAS, this legislation includes provisions regarding school election administrations; and**

**WHEREAS, the Clerk of Birch Run Township and Birch Run School District have entered into an agreement to conduct all elections, including school elections, utilizing municipal precincts and polling locations;**

**AND, WHEREAS, legislation allows for school precincts to be consolidated to contain under 5,000 registered voters.**

**NOW THEREFORE BE IT RESOLVED that the school precincts boundaries will match current voting precincts but will be combined for school elections in the following precincts:**

**Precinct 1: Birch Run Library, 11935 Silver Creek Drive. The portion of voters in Birch Run Schools from Precinct 3 which usually vote at the Township Hall will be assigned to the Library next door for School Elections and voters from Precinct 1 and 2 which usually vote at the Library will be combined into one precinct. This will be around 3,761 voters.**

**Precinct 2: Taymouth Township Hall, 4545 E. Birch Run Road. Precinct one and two will be combine precincts for School Elections with around 3,465 voters.**

**Vienna Charter Township voters will vote in Vienna Charter Township as a split with Clio Schools.**
