Public Hearing(s):

Winters Motor Court – Dangerous Buildings – 10070 Dixie Hwy: 19:05 – 19:13

An overview of the purpose of the hearing was given, along with a breakdown of the packet materials provided. This was the second review of the Proposed Hearing Officer's Decision and Order, and updated report on non-compliance, from Mr. Kern Slucter for the buildings located at 10070 Dixie Hwy. The first review was during the August 26th, 2025, Special Meeting, where Mr. Winters was granted a two-week extension to comply with the Decision and Order.

Mr. Winters told the board that he had been working to comply with the order, but did not have the demo permit from the Township yet. The Clerk confirmed that Mr. Winters had been working with the Building Inspector to get the permit and that the only items now needed for the permit were the verified disconnection of the utilities (Water, Gas, Electrical). Mr. McCree, Area Manager from Consumers Energy, was present at the meeting and said that his team would coordinate with the Township to help expedite any demo of services at the address for the safety of the demolition.

Mr. Winters stated that all tenants were now out of the buildings, and he would continue to work on the disconnection of all utilities from the tenant buildings. The board discussed the next steps and the drafted Resolution #2025-11. Attorney Lindsey Gergel, FSBR Law, was also present for questions on the resolution.
